



**Glenview Park District  
Regular Park Board Meeting  
December 18, 2008**

**HIGHLIGHTS**

The Board of Park Commissioners...

- Approved the November 20, 2008 Regular Park Board meeting minutes.
- Approved Payroll and Accounts Payable for the month of November, 2008 in the amount of \$1,472,008.42.
- Approved the Glenview Service Council as a Recognized Organization. This group is a voluntary coordinating council representing service and volunteer organizations in Glenview.
- Approved the Special Revenue Facilities Committee recommendation to approve the 2009-10 Annual Recommendations for the Tennis Club. There were no significant changes only a minimum fee increase on club memberships of approximately 5%.
- Approved the Special Revenue Facilities Committee recommendation to approve the 2009-10 Annual Recommendations for the Glenview Park Golf Club. The only significant change this year is to the weekend permanent tee time policy. These changes were recommended in an effort to increase the number of permanent tee times sold on Saturday and Sunday.
- Approved the Special Revenue Facilities Committee recommendation to approve the 2009-10 Annual Recommendations for the Glenview National 9. No significant changes.
- Approved the Recreation, Museum, and Swimming Pools Committee recommendation to approve the Annual Recommendations for the Outdoor Pools as presented. Several changes in operations and fee structure were made with the goal of making season passes more attractive to resident families through special discounting opportunities. (see chart). Early Bird fees for individual and additional memberships will be \$10.00 less than last year. Staff has committed to implementing these cost controls without sacrificing service and safety standards.

- Approved the Recreation, Museum, and Swimming Pools Committee recommendation to approve Ordinance 2008-23 which prohibits the use of certain devices in certain parts of Park District buildings and Policy No. 4.60(Camera and Cell Phone Use Restrictions). With the availability of cell phones that have cameras and video recording capabilities, this ordinance and the corresponding administrative policy prohibits the use of cell phones and other recording devices and is intended to protect our staff and patrons in areas such as locker rooms and restrooms where a person has the reasonable expectation of privacy.

\*There will be a meeting on the topic of public access to the Cunliff Park fieldhouse restrooms held on January 12 at 7:00 p.m. at the Cunliff Park Fieldhouse. Invitations to attend the meeting were mailed to 186 residents who live closest to the park.
