#### **1. Roll Call**

President Scholl called the meeting to order at 7:05 p.m. and the roll was called.

#### **2. Public Comment**

President Scholl commented that the purpose of tonight's public hearing is to review the specific components of the proposed application for funds from the State of Illinois 2010 OSLAD grant program. Notice of the public hearing was published in the June 10th edition of the Glenview Announcements.

He noted The Park District is proposing site improvements at Willow Park to include a new playground with safety surfacing, multigenerational game tables, public, accessible bathrooms, an open air shelter, enhanced pathways, site work and landscaping. It is further proposed that the Park District apply for funding with the State of Illinois' Open Space, Land Acquisition and Development grant program in the amount of \$220,000 in matching funds for these improvements.

President Scholl then opened the meeting up for public comments.

With there being no further comments, President Scholl asked for a motion to adjourn the Public Hearing.
