**HIGHLIGHTS**

The Board of Park Commissioners...

- Accepted the September 16, 2013 Administrative Operations Committee meeting minutes.
- Accepted the October 21, 2013 Finance Committee meeting minutes.
- Approved the October 24, 2013 Regular Board meeting minutes.
- Accepted the October 31, 2013 Administrative Operations committee meeting minutes.
- Accepted the November 14, 2013 Combined Recreation, Museum & Swimming Pools/Building, Grounds & Park Services Committee meeting minutes.
- Recognized President Bill Casey and Commissioners Mary Jean Coulson and Ted Przybylo for 10-years of outstanding service, support and leadership they each have provided to the Glenview Park District and the community as board members since 2003.
- Approved Payroll and Accounts Payable for the month of October, 2013 in the amount of \$1,907,427.26.
- Accepted a Recreation, Museum, and Swimming Pools Committee recommendation to approve the 2014-15 Wagner Farm Annual Recommendations. There were no major changes made.
- Accepted a Recreation, Museum, and Swimming Pools Committee recommendation to approve the 2014-15 Grove Annual Recommendations. There were no major changes made.
- Accepted a Recreation, Museum, and Swimming Pools Committee recommendation to approve the 2014-15 Air Station Prairie Annual Recommendations. There were no major changes made.
- Accepted a Recreation, Museum, and Swimming Pools Committee recommendation to approve the 2014-15 Schram Museum Annual Recommendations. There were no major changes made.
- Approved a Buildings, Grounds & Park Services Committee recommendation to approve the 2014-15 Sports Field Rentals and Outdoor Services Annual Recommendations. There was an increase to the annual player use fee for the first time

in 5 years.

- Approved a Buildings, Grounds & Park Services Committee recommendation to approve the 2014-15 Park Facility Operations Annual Recommendations. Rental rates and deposits were increased to help with field house operational costs.
- Approved the updated Glenview Senior Center By-Laws. The East Wing Glenview Senior Center Board proposed a number of minor changes to their by-laws.
- Accepted the Finance Committee recommendation to approve Tax Levy Ordinance 2013-22 for \$15,866,516. The tax levy will fund the Glenview Park District's operations for the fiscal year beginning May 1, 2014. This levy is a reduction of approximately \$131,000 or .84% over the taxes extended in the prior year to existing property on the tax rolls. This is the 3rd year in a row that the District has been able to keep its request for taxes relatively flat for existing properties. The actual impact to individual property owners; however, will vary based on each property's equalized assessed valuation (EAV) as a proportion of the entire EAV within the Glenview Park District's boundaries. The levy also included an estimated \$395,985 or 1.7% in new tax revenue coming entirely from new property potentially being added to the tax rolls. If the estimated EAV from new property does not get added to the tax rolls this year, the County Clerk's office will reduce the levy for the new property.
- Accepted the Finance Committee recommendation to approve Ordinance 2013-23 reducing the Corporate Fund in the 2013 Real Estate Tax Levy for 2014 tax receipts. The PTELL reduction ordinance directs the County Clerk to reduce the corporate levy if needed to comply with the Property Tax Extension Limitation Law. This is an annual housekeeping item.
- Accepted a Special Revenue Facilities Committee recommendation to take the Glenview Park Golf Club Renovations Project to the Bidding Stage. The Committee reviewed the project scope as well as an estimated budget for the Glenview Park Golf Club renovation project. The project will go out to bid in January of 2014 and the Board will consider those bids at their February meeting.
- Approved the October 24, 2013 Executive Session meeting minutes.
