**Team Captains Information Letter**

Captains, now is time to start thinking about fall softball. In order to participate this season, you will need to know the following information.

1. First priority will be given to teams that played last year. Second priority will be teams that played in our 2018 summer league. New teams will be accepted in the order received if there is available space.
2. Games will be played at Community Park West, 1001 Zenith Drive. Games begin at 7:00 PM. Games are played on Tuesday nights. **Games may be scheduled on Wednesday or Thursday nights or as double headers if necessary.**
3. Glenview Park District League Description
  - **League Fee - \$591 – teams that drop out after the registration deadline date of August 8 will receive a 50% refund of their league fee. Teams that drop out after schedules are created will receive NO REFUND.**
  - Additional non-resident fees are no longer in effect.
  - Forfeit fees will no longer be paid in advance. **If your team forfeits, you must pay the forfeit fee (\$32.00 per game) prior to participating in your next game.**
  - Forfeit logs will be kept during the season. Any team with an excessive number of forfeits may be released from the league with no refund at the discretion of the Athletic Supervisor. **Athletic Supervisor's decision in the manner is FINAL.**
  - League champions receive a \$250 award and a trophy. Tournament champion receives a \$100 award and a trophy.
  - All teams participate in post-season tournament.
  - Season schedule is seven (7) games.
  - **League fee of \$591 is due IN FULL by Wednesday, August 8. Deposits or partial payments will not be accepted.**
  - Team roster/waiver forms will be handed out at your team's first scheduled game.
  - All players must complete their own information and sign their own names before they are eligible for league play.
  - Rosters will be kept on site at CPW. If you need to make edits to your roster, see the Field Supervisor who will obtain the roster for you. After making your changes, return the roster to the Field Supervisor.
