The Glenview Grizzlies House League gives players ages 5-16 the opportunity to play in a "recreational" league where participation, skill development and sportsmanship are the primary objectives.

The Ice Center's Hockey Director, Sylvain Turcotte and his professional staff work side-by-side with volunteer coaches to develop young athletes as hockey players and equally important, as individuals.

Note: USA Hockey rules prohibit travel hockey players from participating in this program at any level.

During the regular season, players can expect to be on the ice twice a week, with one game and one practice. Team assignments will be made after the two week rating session.

Online registration is available at glenviewparks.org. Your USA Hockey confirmation number is needed when registering.**

EQUIPMENT: A game jersey and game socks are included in the league registration fee. All other equipment must be provided by each player, with the exception of goalie equipment for Dynamites through Squirts. Full equipment is required for participation. Refer to the Glenview Ice Center's Hockey Handbook for the list of equipment.

INSURANCE: The Park District does not provide insurance to participants in the Youth League program. Players do participate in a limited USA Hockey insurance program with USA Hockey Registration.

****USA HOCKEY REGISTRATION:** Required to participate in clinics and leagues. Follow this link to register your player with USA Hockey, https://www.usahockeyregistration.com/login_input.action. The cost to each participant is \$59. Players born in 2013 and later are free.

RATING SESSIONS: The first two weeks of the program consists of rating sessions. These sessions allow players to prepare for the upcoming season and for staff to rate each player's skill level for the purpose of creating balanced teams. These ratings are used at a blind draft for team formation. When you register, you sign up for the rating session group which best fits your schedule during the two weeks. Once teams are formed, each player will receive their team's schedule. Practices begin in late September.

2019-20 Youth League facilities! During the renovation project the Glenview Youth League will be utilizing neighboring rinks. Jet Hockey Training Arena (Jet-Ice), Northbrook and North Shore Ice Arena will all serve as our home rinks for this transition season.

PLAYER LEVEL DESCRIPTIONS

DYNAMITES (players born in 2013 and after) The majority of Dynamite players have developed basic skills through our Development Hockey program and will continue to receive instruction at this level. All practices and games are held at Jet-Ice where skills can be better developed.

MITES (players born in 2011 & 2012) • **SQUIRTS** (players born 2009 & 2010) Mite & Squirt players will practice at Northbrook, North Shore and Jet-Ice. Games take place at Northbrook where full ice games will develop team strategies. Mites and squirts in-house divisions will include Northbrook teams. Thank you to the Northbrook Hockey League for facilitating this partnership.

PEEWEEES (players born in 2007 & 2008) **BANTAMS** (players born in 2005 & 2006) • **MIDGETS** (players born in 2002, 2003 & 2004) Players at these levels will utilize the Northbrook and North Shore for the majority of their ice time. Attendance at team practices is expected. Pee wee teams may and Bantam teams will compete in the North Shore Youth Hockey League and play against teams from Glenview and other area rinks. Our midget team participates in the Northwest Suburban Hockey League. All member rinks are within a 30-minute drive from Glenview.

REGISTRATION PROCEDURES

Register at www.glenviewparks.org. Your USA Hockey confirmation** number is needed when registering. Register online with USA Hockey at www.usahockey.com.

Rating sessions will be filled on a first come first-served basis. Register early to ensure participation in your first choice session, as rating sessions fill up very quickly.

Squirt through midget goalies get a discounted rate of R \$400/NR \$500.

* If you select a payment plan, you must complete the Payment Plan portion of the registration form. A minimum 20% deposit must accompany your registration form and you must include a valid Visa, MasterCard or Discover number with expiration date on the form.
